Aurora, Nebraska April 14, 2009

A meeting of the Mayor and Council of the City of Aurora, Nebraska, was convened in open and public session at 7:30 p.m. on April 14, 2009 at the City Hall. Present were Councilors: Wayne Roblee, Bruce Ramsour, Dottie Anderson, Chris Helzer, Dick Phillips and Paul Shaneyfelt. Mayor Marlin Seeman conducted the meeting. City Officials present were City Administrator Mike Bair, City Attorney Ross Luzum, Police Chief Godfrey Brokenrope, Water/Sewer Commissioner Rick Melcher and Clerk/Treasurer Barbra Mikkelsen.

Notice of said meeting was given by publication in the Aurora News Register on April 8, 2009. Notice of meeting was simultaneously given to the Mayor and all members of the Council and a copy of their acknowledgment of receipt of notice and the agenda is attached to these minutes. Availability of the agenda of this meeting was communicated in the advance notice and in the notice to the Mayor and Council. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

MINUTES:

Councilor Phillips moved to approve the minutes from the March 24, 2009 meeting. Councilor Anderson seconded the motion. Voting Aye: Ramsour, Anderson, Helzer, Phillips, Shaneyfelt and Roblee. Nay: None. The motion carried.

PETITIONS, COMPLAINTS, COMMUNICATIONS:

REPORTS BY OFFICERS, BOARD, COMMITTEES:

Clerk/Treasurer Mikkelsen presented the Expenditure and Clerk/Treasurer reports for the month ending March 31, 2009. Councilor Ramsour moved to approve said reports. Councilor Helzer seconded the motion. Voting Aye: Anderson, Helzer, Phillips, Shaneyfelt, Roblee and Ramsour. Nay: None. The motion carried.

Claims Committee Chairperson Helzer reported the claims presented by the Clerk were in order and moved that said claims be allowed and checks drawn on the various funds for payment of same be approved. Mayor Seeman began the hearing to hear testimony and receive evidence relative to the structure located at 1127 and 1129 12th Street, and make a written finding of fact as to whether it is a dangerous building. Jason Suelter, City Building Inspector gave a report on the condition of the building. Discussion was held and various questions were answered regarding the building and the procedures that need to be followed.

Councilor Shaneyfelt moved to approve Resolution 09-14 declaring the structure located at 1127 12th Street to be unsafe. Councilor Phillips seconded the motion. In the event the owner fails to comply the City will take any of the following courses of action or any combination thereof:

- The City shall proceed with the aforementioned work and levy the cost as a special assessment against the lot or real estate upon which the building is located, such special assessment shall be a lien on the real estate and shall be collected in the manner provided for special assessments;
- 2) The City shall proceed with the aforementioned work and collect the cost from the owner of the building and enforce the collection by civil action in any court of competent jurisdiction; and/or
- 3) The City shall file a criminal petition against the owner in any court of competent jurisdiction for non-compliance, which on conviction shall be deemed a misdemeanor and result in a fine of not more than five hundred Dollars (\$500.00), a new violation being committed every twenty-four (24) hours of such failure to comply, included with an order of abatement as a part of the judgment in the case.

Mayor Seeman opened the duly advertised public hearing to hear public comments regarding amending Ordinance No. 708 and the Land Use Plan to reflect changes in zoning for the property located at, Block 1, Original Town, Village Of Hamilton an Addition to the City of Aurora, Hamilton County, Nebraska.

Mayor Seeman asked if there was anyone present who wished to speak in favor of or in opposition to the recommendation. Zoning Administrator Melcher explained the zoning change request. He also stated the Planning Commission was recommending approval of the change. There being no one else present that wished to speak in favor of or in opposition to the recommendation the Mayor declared the public hearing closed.

City Attorney Luzum read Ordinance No. 931 by its title: AN ORDINANCE TO AMEND ORDINANCE 708, THE ZONING ORDINANCE OF THE CITY OF AURORA, NEBRASKA, ARTICLE FOUR (4), ESTABLISHMENT AND DESIGNATION OF ZONING DISTRICTS, SECTION 403, THE OFFICIAL ZONING MAP, TO PROVIDE THAT THE PROPERTY LEGALLY DESCRIBED AS: A REPLAT OF BLOCK 1, ORIGINAL TOWN, VILLAGE OF HAMILTON AN ADDITION TO THE CITY OF AURORA, HAMILTON COUNTY, NEBRASKA, BE CHANGED FROM R-1, RESIDENTIAL DISTRICT DESIGNATION TO R-2, RESIDENTIAL DISTRICT DESIGNATION AND TO PROVIDE THAT SAID CHANGE SHALL BE ENTERED UPON ZONING MAP AS PROVIDED IN ARTICLE 4, SECTION 404.10, OFFICIAL ZONING MAP CHANGES.
