### Aurora, Nebraska April 12, 2011

Notice of meeting was simultaneously given to the Mayor and all members of the Council and a copy of their acknowledgment of receipt of notice and the agenda is attached to these minutes. Availability of the agenda of this meeting was communicated in the advance notice and in the notice to the Mayor and Council. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

#### **REPORTS BY OFFICERS, BOARD, COMMITTEES:**

Clerk/Treasurer Mikkelsen presented the Expenditure and Clerk/Treasurer reports for the month ending March 31, 2011. Councilor Roblee moved to approve said reports. Councilor Shaneyfelt seconded the motion. Voting Aye: Lackore, Hupf, Shaneyfelt, Roblee and Ramsour. Absent and not voting: Phillips. Nay: None. The motion carried.

Jeremy Eschliman from the Central District Health Department (CDHD) discussed Public Health Month and the CDHD's role in working with communities to address their health concerns. Mayor Seeman presented the following Proclamation of Public Health Month.

## Central District Health Department Public Health Month Proclamation April 2011

Whereas, Central Nebraskans have achieved almost 30 additional years of life expectancy since 1900; and

Whereas, public health efforts are credited with the majority of improvements in our health status and expanded life expectancy; and

Whereas, Central Nebraska has had a district health department since 2002; and

Whereas, the Central District Health Department identifies and addresses patterns of disease, illness and injury in populations; and

Whereas, the Central District Health Department is about ensuring healthy living and working environments; and

Whereas, the Central District Health Department protects against bioterrorism and new and emerging public health threats; and

Whereas, public health measures such as controlling the spread of disease, maintaining safe food and drinking water, and providing maternal and child health services, have prevented deaths and improved our quality of life; and

Whereas, public health services benefit all Central Nebraskans, regardless of age, culture or race; and

Whereas, public health services result in healthy people in healthy communities; and

Whereas, it is important that we do not take public health for granted and that we recognize the need to maintain and improve our current public health efforts.

Now, Therefore, I, Marlin Seeman, Mayor of the City of Aurora hereby proclaim April as Central Nebraska Public Health Month.

Councilor Roblee moved to approve the request from Deb Kalkwarf of Grandview Café for a special liquor license and permission to fence off the street east of the alley between 11th and 12th Street on "L" Street to hold an outdoor beer garden and street dance during Aurora "N" Days, June 24 and June 25, 9:00pm to 12:00pm both days. Councilor Shaneyfelt seconded the motion. Voting Aye: Roblee, Ramsour, Lackore, Hupf and Shaneyfelt. Nay: None. Absent and not voting: Phillips. The motion carried. Councilor Shaneyfelt moved to approve a Noise Control Special Variance Application from Deb Kalkwarf for Grandview Café, for June 24 and June 25 to have a beer garden and street dance from 9:00 pm to 12:00pm both days. Councilor Lackore seconded the motion. Voting Aye: Ramsour, Lackore, Hupf, Shaneyfelt and Roblee. Nay: None. Absent and not voting: Phillips. The motion carried.

Grant Administrator reviewed the amendment to the EECBG Aid Agreement for the energy grant. Councilor Ramsour moved to approve the amendment to the EECBG Aid Agreement. Councilor Roblee seconded the motion. Voting Aye: Lackore, Hupf, Shaneyfelt, Roblee and Ramsour. Nay: None. Absent and not voting: Phillips. The motion carried.
